2. The State with its Open Data Policy, which was launched in the year 2016 has revolutionised itself in the open data platform and further opened up government data of potential applications. The core thought of Telangana's Open Data policy is aimed at transparency and also which enable wider scope for Startups and other companies to address public issues by finding out solutions by using the datasets made available.

3. The Open Data Policy of Government of Telangana is also being supported by the Open Data Platform which acts as the central repository system of all the datasets of the Government of Telangana and will be in the public domain.
